What Are Batches?
Batches are utilized in tracking
ARMY LEOSA applications, ONLY.

Batches are how applications are grouped when they are received and logged by our offices. When confirmation receipt e-mails are sent, you are assigned a 'Batch #'. This indicates the group that your application will be reviewed with. Once DCS completes an initial review of the applications in a batch, completed applications are put on a LIST to be sent to the PM for final approval. If your application is incomplete, incorrect, or is held up by the PM when the LIST is being assembled, you will not be put on a list until your application is completed, regardless of the initial batch you were assigned.

DCS is extremely excited to announce the launch of the newly designed and fully automated LEOSAOnline.com website! This enhanced customer experience will provide ease in applying. THE NEW WEBSITE ONLY AFFECTS AIR FORCE AND ARMY LEOSA CUSTOMERS AS THE NAVY HAS NOT YET ADOPTED THE NEW AUTOMATED PROCESS.

During the 2014 stand-up of the USAF LEOSA program, DCS proposed a completely automated online application process. It was the belief that DCS would be able to host the LEOSAOnline.com website as a secure site on the DOD server, but this was not the case. DCS was unable to proceed with the automated process due to DOD regulations thus requiring customers to submit hand-written or typed paper applications. This cumbersome process proved to be time consuming and inefficient for both the customer and DCS. DCS spent countless hours lobbying the government for change and has received modifications to the Air Force and Army contracts. These contract modifications allow DCS to utilize Amazon Web Services Gov (AWSG), a completely secure, DOD-certified cloud provider that accommodates all DOD Personally Identifiable Information (PII) requirements.

This new platform provides a new application process that is not only less time consuming, but more efficient and user-friendly. The updated site now allows for a completely automated, online experience. All account information and application questions will be answered directly within your LEOSAOnline.com account. Digital uploading is now required for all photos, application documents, and the Service Request option can now be completed online! Customers NO LONGER need to mail in applications, additional documentation, or service requests!

The new website conveniently allows customers to log-in and out of their accounts without losing information. Accounts feature a tracking bar that show completed steps in green and incomplete or required action steps in red. Customers will be updated on the status of their application via e-mail through their online accounts. DCS believes these new features will increase user-friendliness and greatly improve the application process for everyone!

Heidi L. Scheppers, a member of the Senior Executive Service, is the Deputy Director of Security Forces, Deputy Chief of Staff for Logistics, Engineering and Force Protection, Headquarters U.S. Air Force, Washington, D.C. Batch 45 is currently being assembled at our San Antonio office. Applications that are not ready are dropped back to the next List.


Navy LEOSA

Requirement Support Officer (RSO) for Integrated Base Defense Security System (IBDSS)

Requirements Support Officer (RSO(s) will support force protection and the integration of sensor technology initiatives for Protection Level 1-4 resources under the Air Force Integrated Base Defense Security System (IBDSS) program. IBDSS for Protection Level 1-4 encompasses projects which include command, control and display systems, intrusion/explosion detection equipment, access control systems, video assessment and surveillance systems, non-lethal weapons, and active and passive delay and denial systems. The RSO(s) will be involved in system and equipment upgrades including commercial off-the-shelf (COTS) and government off the shelf systems (GOTS) that are considered as replacements for fielded systems by Air Force (AF) operational commands. The majority of IBDSS equipment is dependent of information technology (IT) systems for functionality. Sensor test, evaluation and turn over activities are planned for each potential system or piece of equipment developed under the IBDSS umbrella. The RSO(s) will be required to travel within the Continental United States (CONUS) and Outside the Continental United States (CONUS) as mission requirements dictate.

SPECIAL QUALIFICATIONS: At a minimum, all contract personnel shall:

1. Be a US citizen

- 2. Understand and be knowledgeable of the current requirements process
 - 3. Acquired experience as the designated lead of a project or program
- 4. Understand the funding process associated with the project life-cycle cost
- **5. Knowledge of the Program Objective Memorandum (POM) funding process**
- 6. Understand inventory management and life cycle replacement for equipment requirements
 - 7. Understand systems/security requirements
- 8. Have recent knowledge and experience with DoD and USAF installation security and force
 9. protection security systems and procedures
 - 10. Have a working knowledge of computers, Microsoft Windows, Microsoft Project, and Microsoft Office software
 - 12. Present a professional appearance, and wear badges identifying them as contractors
- 13. Must maintain personal suitability standards to assure security clearance guidelines are followed throughout the course of employment with DCS

14. Active SECRET Clearance required

15. Willing to travel CONUS & OCONUS
